## **Inhalation:**

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. If patient finds breathing difficult and develops a bluish discolouration of the skin (which suggests a lack of oxygen in the blood - cyanosis), ensure airways are clear of any obstruction and have a qualified person give oxygen through a face mask. Apply artificial respiration if patient is not breathing. Seek immediate medical advice.

## **Skin Contact:**

If spilt on large areas of skin or hair, immediately drench with running water and remove clothing. Continue to wash skin and hair with plenty of water (and soap if material is insoluble) until advised to stop by the Poisons Information Centre or a doctor.

## **Eye Contact:**

Immediately wash in and around the eye area with large amounts of water for at least 15 minutes. Eyelids to be held apart. Remove clothing if contaminated and wash skin. Urgently seek medical assistance. Transport promptly to hospital or medical centre.

## **Ingestion:**

Immediately rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water. Never give anything by the mouth to an unconscious patient. Seek immediate medical assistance.

## **Indication of immediate medical attention and special treatment needed:**

Treat symptomatically. Can cause corneal burns. Delayed pulmonary oedema may result. No known specific antidote.

## **5. FIRE FIGHTING MEASURES**

## **6. ACCIDENTAL RELEASE MEASURES**

### **Emergency procedures/Environmental precautions:**

Isolate spill or leak area immediately. Clear area of all unprotected personnel. If contamination of sewers or waterways has occurred advise local emergency services.

### **Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:**

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal.

## Precautions for safe handling:

Avoid skin and eye contact and breathing in vapour, mists and aerosols. Avoid aerosol formation. Keep out of reach of children.

## Conditions for safe storage, including any incompatibilities:

Store in a cool, dry, well ventilated place and out of direct sunlight. Store away from foodstuffs. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for leaks.

## 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

**Control Parameters:** No value assigned for this specific material by Safe Work Australia. However, Workplace Exposure Standard(s) for constituent(s):

Glutaraldehyde: Peak Limitation = 0.41 mg/m<sup>3</sup> (0.1 ppm), Sen

As published by Safe Work Australia Workplace Exposure Standards for Airborne Contaminants.

Peak Limitation - a maximum or peak airborne concentration of a particular substance determined over the shortest analytically practicable period of time which does not exceed 15 minutes.

'Sen' Notice - sensitiser. The substance can cause a specific immune response in some people. An affected individual may subsequently react to exposure to minute levels of that substance and should not be further exposed to the substance.

These Workplace Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These workplace exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

## Appropriate engineering controls:

Ensure ventilation is adequate and that air concentrations of components are controlled below quoted Workplace Exposure Standards. Keep containers closed when not in use.

<b>Ingestion:</b>	Swallowing can result in nausea, vomiting, diarrhoea, abdominal pain and chemical burns to the gastrointestinal tract.

**Acute toxicity:** No LD50 data available for the product.

**Chronic effects:** For Glutaraldehyde 50% Solution: The substance was mutagenic in various cell culture test systems; however, these results could not be confirmed in tests with mammals. In long-term animal studies in which the substance was given in the drinking water in high concentrations, a carcinogenic effect was not observed. No teratogenic effects were observed in animal studies.
