### 2. HAZARDS IDENTIFICATION

Classified as Dangerous Goods by the criteria of the Australian Dangerous Goods Code (ADG Code) for Transport by Road and Rail; DANGEROUS GOODS.

This material is hazardous according to Safe Work Australia; HAZARDOUS CHEMICAL.

### 4. FIRST AID MEASURES

For advice, contact a Poisons Information Centre (e.g. phone Australia 131 126; New Zealand 0800 764 766) or a doctor.

#### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. If patient finds breathing difficult and develops a bluish discolouration of the skin (which suggests a lack of oxygen in the blood - cyanosis), ensure airways are clear of any obstruction and have a qualified person give oxygen through a face mask. Apply artificial respiration if patient is not breathing. Seek immediate medical advice.

#### Skin Contact:

If spilt on large areas of skin or hair, immediately drench with running water and remove clothing. Continue to wash skin and hair with plenty of water (and soap if material is insoluble) until advised to stop by the Poisons Information Centre or a doctor.

### Eye Contact:

Immediately wash in and around the eye area with large amounts of water for at least 15 minutes. Eyelids to be held apart. Remove clothing if contaminated and wash skin. Urgently seek medical assistance. Transport promptly to hospital or medical centre.

#### Ingestion:

Immediately rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water. Seek immediate medical assistance.



### Indication of immediate medical attention and special treatment needed:

Treat symptomatically. Material is strongly acidic and corrosive. Can cause corneal burns.

### **5. FIRE FIGHTING MEASURES**

#### Suitable Extinguishing Media:

Not combustible, however, if material is involved in a fire use: Fine water spray, normal foam, dry agent (carbon dioxide, dry chemical powder).

### Hazchem or Emergency Action Code: 2R

#### Specific hazards arising from the chemical:

Non-combustible material. Corrosive substance.

### Special protective equipment and precautions for fire-fighters:

Decomposes on heating emitting toxic fumes. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to products of decomposition. Heating can cause expansion or decomposition of the material, which can lead to the containers exploding. If safe to do so, remove containers from the path of fire.

### 6. ACCIDENTAL RELEASE MEASURES

### Emergency procedures/Environmental precautions:

Clear area of all unprotected personnel. If contamination of sewers or waterways has occurred advise local emergency services.

### Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Neutralise residues with lime or soda ash. Collect and seal in properly labelled containers or drums for disposal. Wash area down with excess water.

### 7. HANDLING AND STORAGE

This material is a Scheduled Poison S6 and must be stored, maintained and used in accordance with the relevant regulations.

### Precautions for safe handling:

Avoid skin and eye contact and breathing in vapour, mists and aerosols. Keep out of reach of children. Always add the acid to water, never the reverse.

#### Conditions for safe storage, including any incompatibilities:

Store in a cool, dry, well ventilated place. Store away from foodstuffs. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for leaks.

### 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

**Control Parameters:** No value assigned for this specific material by Safe Work Australia. However, Workplace Exposure Standard(s) for constituent(s):

Hydrogen chloride: Peak Limitation = 7.5 mg/m<sup>3</sup> (5 ppm)



As published by Safe Work Australia Workplace Exposure Standards for Airborne Contaminants.

Peak Limitation - a maximum or peak airborne concentration of a particular substance determined over the shortest analytically practicable period of time which does not exceed 15 minutes.

These Workplace Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These workplace exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

### Appropriate engineering controls:

Ensure ventilation is adequate and that air concentrations of components are controlled below quoted Workplace Exposure Standards. Keep containers closed when not in use.

If in the handling and application of this material, safe exposure levels could be exceeded, the use of engineering controls such as local exhaust ventilation must be considered and the results documented. If achieving safe exposure levels does not require engineering controls, then a detailed and documented risk assessment using the relevant Personal Protective Equipment (PPE) (refer to PPE section below) as a basis must be carried out to determine the minimum PPE requirements.

### Individual protection measures, such as Personal Protective Equipment (PPE):

## **10. STABILITY AND REACTIVITY**

Reactivity:	Reacts with alkalis.
Chemical stability:	Stable under normal conditions of use.
Possibility of hazardous reactions:	Corrosive to many metals liberating flammable hydrogen gas. May react with strong oxides .
Conditions to avoid:	Avoid contact with foodstuffs. Avoid exposure to heat.

## 11. TOXICOLOGICAL INFORMATION

No adverse health effects expected if the product is handled in accordance with this Safety Data Sheet and the product label. Symptoms or effects that may arise if the product is mishandled and overexposure occurs are:

Ingestion:	Swallowing can result in nausea, vomiting, diarrhoea, abdominal pain and chemical burns to the gastrointestinal tract. Swallowing will cause corrosion and damage to the gastrointestinal tract.
Eye contact:	A severe eye irritant. Corrosive to eyes; contact can cause corneal burns. Contamination of eyes can result in permanent injury.
Skin contact:	Contact with skin will result in severe irritation. Corrosive to skin - may cause skin burns.
Inhalation:	Breathing in mists or aerosols will produce respiratory irritation. May cause coughing and shortness of breath.

Acute toxicity: No LD50 data available for the product. However, for constituent(s) HYDROGEN CHLORIDE: (1): Oral LD50 (rabbit): 900 mg/kg Inhalation LC50 (rat): 3124 ppm/1h. Inhalation LC50 (mice): 1108 ppp/1h.

**Chronic effects:** Repeated exposure to low levels of hydrochloric acid may produce discolouration and erosion of teeth and ulceration of the nasal passages.
