# 4. FIRST AID MEASURES

#### Special protective equipment and precautions for fire-fighters:

On burning will emit toxic fumes, including those of oxides of sulfur. Keep containers cool with water spray. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to products of decomposition.

Clear area of all unprotected personnel. Shut off all possible sources of ignition. If contamination of sewers or waterways has occurred advise local emergency services.

Wear protective equipment to prevent skin and eye contact and breathing in dust. Sweep up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal. Use non-sparking tools. After cleaning, flush away any residual traces with water.
