Glass oxide (Glass fiber or Glass reinforcements), 0-50%

Flame retardants (flame retardant grades only), 0-20%  
Other polymeric modifiers, 0-20%  
Colourants, additives and processing aids, 0-10%

## 4. FIRST AID MEASURES

**Inhalation:**

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

## **Skin Contact:**

If skin contact occurs, remove contaminated clothing and wash skin with running water. If irritation occurs seek medical advice. If molten material should contact the skin and adhere, cool quickly with running water - do not attempt to remove. Seek immediate medical assistance.

## **Eye Contact:**

If in eyes, wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice. For contact with the molten material treat as for skin burns.

## **Ingestion:**

Rinse mouth with water. If swallowed, give a glass of water to drink. If vomiting occurs give further water. Seek medical advice.

## **Indication of immediate medical attention and special treatment needed:**

Treat symptomatically.

## **5. FIRE FIGHTING MEASURES**

### **Suitable Extinguishing Media:**

Fine water spray, normal foam, dry agent (carbon dioxide, dry chemical powder).

### **Specific hazards arising from the chemical:**

Combustible solid.

### **Special protective equipment and precautions for fire-fighters:**

On burning will emit toxic fumes. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.

## **6. ACCIDENTAL RELEASE MEASURES**

### **Emergency procedures/Environmental precautions:**

If contamination of sewers or waterways has occurred advise local emergency services.

### **Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:**

Slippery when spilt. Avoid accidents, clean up immediately. Shut off all possible sources of ignition. Wear protective equipment to prevent skin and eye contact and breathing in dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal.

## **7. HANDLING AND STORAGE**

### **Precautions for safe handling:**

Avoid skin and eye contact and breathing in dust. Avoid handling which leads to dust formation. Take precautionary measures against static discharges.

### **Conditions for safe storage, including any incompatibilities:**

Store in a cool, dry, well ventilated place. Keep containers closed when not in use - check regularly for spills.
