Methods and material for containment and cleaning up

Methods for containment Stop leak if you can do it without risk. Remove ignition sources. Provide adequate ventilation. Do not touch or walk through spilled material. Dike far ahead of spill to collect runoff water. Keep out of drains, sewers, ditches and waterways. Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal.

Methods for cleaning up Slippery when spilt. Avoid accidents, clean up immediately. Dam up. Soak up with inert absorbent material. Use non-sparking tools. Use personal protective equipment as required. Pick up and transfer to properly labelled containers.

7. HANDLING AND STORAGE

Precautions for safe handling

Advice on safe handling Avoid contact with skin, eyes, and clothing. Avoid breathing vapors or mists. Take precautionary measures against static discharges. Wash thoroughly after handling. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Use according to package label instructions. 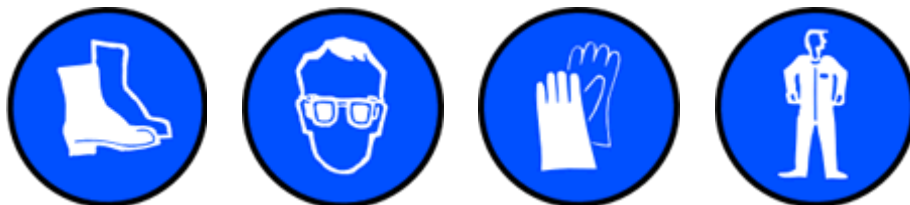
