Methods and material for containment and cleaning up

Dike far ahead of spill to collect runoff water. Keep out of drains, sewers, ditches and waterways. Remove ignition sources. Provide adequate ventilation. Absorb or cover with dry earth, sand or other non-combustible material and transfer to containers.

Methods for cleaning up Take precautionary measures against static discharges. Dam up. Soak up with inert absorbent material. Pick up and transfer to properly labelled containers.
