## **6. ACCIDENTAL RELEASE MEASURES**

Evacuate personnel to safe areas. Do not touch or walk through spilled material. Keep people away from and upwind of spill/leak. ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Pay attention to flashback. Take precautionary measures against static discharges. All equipment used when handling the product must be grounded.

**Methods and material for containment and cleaning up**

**Methods for containment** Stop leak if you can do it without risk. Do not touch or walk through spilled material. A vapor suppressing foam may be used to reduce vapors. Dike far ahead of spill to collect runoff water. Keep out of drains, sewers, ditches and waterways. Remove ignition sources. Provide adequate ventilation. Absorb or cover with dry earth, sand or other non-combustible material and transfer to containers.

**Methods for cleaning up** Slippery when spilt. Avoid accidents, clean up immediately. Dam up. Soak up with inert absorbent material. Use non-sparking tools. Pick up and transfer to properly labelled containers.

## **7. HANDLING AND STORAGE**

**Precautions for safe handling**

No smoking. Use grounding and bonding connection when transferring this material to prevent static discharge, fire or explosion. Use with local exhaust ventilation. Use spark-proof tools and explosion-proof equipment. Take precautionary measures against static discharges. Keep in an area equipped with sprinklers. Take off contaminated clothing and wash before reuse. Wash thoroughly after handling. Use personal protection equipment. Use according to package label instructions.

**General hygiene considerations** Remove and wash contaminated clothing and gloves, including the inside, before re-use. Contaminated work clothing should not be allowed out of the workplace. Regular cleaning of equipment, work area and clothing is recommended. Wash hands before breaks and immediately after handling the product. Avoid contact with skin, eyes, and clothing.
