Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal.

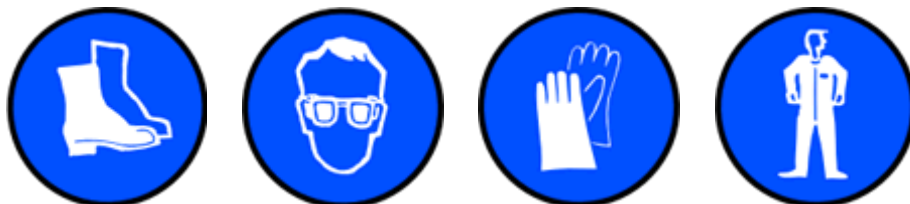
