4. FIRST AID MEASURES

Inhalation:

**Skin Contact:**

If skin contact occurs, remove contaminated clothing and wash skin with running water. If irritation occurs seek medical advice.

If in eyes, wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice.

Ingestion:

Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water. If vomiting occurs, the head should be kept low so that vomit does not enter the lungs. Never give anything by the mouth to an unconscious patient. Seek medical advice.

5. FIRE FIGHTING MEASURES

Normal foam, dry agent (carbon dioxide, dry chemical powder).

Specific hazards arising from the chemical:

Combustible liquid. On burning will emit toxic fumes, including those of oxides of carbon.

Special protective equipment and precautions for fire-fighters:

Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion. Keep containers cool with water spray.

6. ACCIDENTAL RELEASE MEASURES

Emergency procedures/Environmental precautions:

Shut off all possible sources of ignition. If contamination of sewers or waterways has occurred advise local emergency services.

Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. Collect contaminated rinse water, do not allow to reach sewage or effluent systems.

7. HANDLING AND STORAGE

Classified as a C2 (COMBUSTIBLE LIQUID) for the purpose of storage and handling, in accordance with the requirements of AS 1940. Refer to State Regulations for storage and transport requirements.

Precautions for safe handling:

Avoid skin and eye contact and breathing in vapour, mists and aerosols. When using do not eat, drink or smoke. Wash thoroughly after handling.

Conditions for safe storage, including any incompatibilities:

Store in a cool, dry, well ventilated place and out of direct sunlight. Store away from sources of heat or ignition. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for leaks.

8. EXPOSURE CONTROLS/PERSONAL PROTECTION

Vegetable oil mists (except castor oil, cashew nut or similar irritant oils): 8hr TWA = 10 mg/m³

TWA - The time-weighted average airborne concentration of a particular substance when calculated over an eight-hour working day, for a five-day working week.
