### **Precautions for safe handling**

**Advice on safe handling** Avoid breathing dust or spray mist. Avoid contact with skin, eyes or clothing. Avoid generation of dust. Take precautionary measures against static discharges. Use personal protection equipment. Ensure adequate ventilation. Use with local exhaust ventilation. Keep away from open flames, hot surfaces and sources of ignition. Use according to package label instructions. Handle in accordance with good industrial hygiene and safety practice. Do not eat, drink or smoke when using this product.
