Specific hazards arising from the chemical:

Flammable liquid. On burning will emit toxic fumes, including those of oxides of carbon.

Special protective equipment and precautions for fire-fighters:

Heating can cause expansion or decomposition of the material, which can lead to the containers exploding. If safe to do so, remove containers from the path of fire. 6. ACCIDENTAL RELEASE MEASURES

Emergency procedures/Environmental precautions:

Shut off all possible sources of ignition. Clear area of all unprotected personnel. If contamination of sewers or waterways has occurred advise local emergency services.

Personal precautions/Protective equipment/Methods and materials for containment and cleaning up: Slippery when spilt. Avoid accidents, clean up immediately. 7. HANDLING AND STORAGE
