**Specific hazards arising from the chemical** Combustible solid. On burning will emit toxic fumes, including those of oxides of carbon. Dust can form an explosive mixture with air. **Methods and material for containment and cleaning up**

**Methods for containment** Stop leak if you can do it without risk. Remove ignition sources. Provide adequate ventilation. Soak up condensate with inert absorbent material and collect in ventilated waste container for disposal.

**Methods for cleaning up** Slippery when wet. Cover with damp absorbent (inert material, sand or soil). Vacuum or sweep material and place in a disposal container. Use non-sparking tools. Avoid generation of dust. Pick up and transfer to properly labelled containers.

## **7. HANDLING AND STORAGE**

**Precautions for safe handling**

**Advice on safe handling** Avoid breathing dust or spray mist. Avoid contact with skin, eyes, and clothing. Avoid generation of dust. Take precautionary measures against static discharges. Use personal protection equipment. Keep away from open flames, hot surfaces and sources of ignition. Use according to package label instructions. Handle in accordance with good industrial hygiene and safety practice.
