#### **General advice**

Remove to fresh air and keep at rest in a position comfortable for breathing. Call a physician if symptoms occur.

#### **Eye contact**

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Keep eye wide open while rinsing. Do not rub affected area. Remove contact lenses, if present and easy to do. Continue rinsing. Call a physician immediately.

#### **Skin contact**

Wash skin with soap and water. Get medical attention if irritation develops and persists.

#### **Ingestion**

Clean mouth with water and drink afterwards plenty of water. Do NOT induce vomiting. Get

**Specific hazards arising from the chemical** Combustible solid. On burning will emit toxic fumes, including those of oxides of carbon. In the event of fire, cool tanks with water spray. **Personal precautions** Avoid contact with skin, eyes, and clothing. Avoid breathing dust or spray mist. Ensure adequate ventilation. Do not touch or walk through spilled material. Keep people away from and upwind of spill/leak. Evacuate personnel to safe areas. Wash thoroughly after handling. Use personal protective equipment as required.

**For emergency responders** Shut off ignition sources. Clear area of all unprotected personnel. Use personal protection recommended in Section 8.

**Methods and material for containment and cleaning up**

**Methods for containment** Stop leak if you can do it without risk. Do not touch or walk through spilled material. Remove ignition sources. Provide adequate ventilation. Dike far ahead of spill to collect runoff water. Soak up condensate with inert absorbent material and collect in ventilated waste container for disposal.

**Methods for cleaning up** Dam up. Cover with damp absorbent (inert material, sand or soil). Vacuum or sweep material and place in a disposal container. Avoid generation of dust. Use non-sparking tools. Collect in properly labelled containers for disposal.

## 7. HANDLING AND STORAGE

### Precautions for safe handling

**Advice on safe handling** Avoid contact with skin, eyes, and clothing. Avoid breathing dust or spray mist. Avoid generation of dust. Take precautionary measures against static discharges. Keep away from open flames, hot surfaces and sources of ignition. Use personal protection equipment. Use according to package label instructions. Handle in accordance with good industrial hygiene and safety practice.

**General hygiene considerations** Regular cleaning of equipment, work area and clothing is recommended. Wash hands and face before breaks and immediately after handling the product.
