Methods for containment

Stop leak if you can do it without risk. A vapor suppressing foam may be used to reduce vapors. Dike far ahead of spill to collect runoff water. Keep out of drains, sewers, ditches and waterways. Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal.

Methods for cleaning up

Slippery when spilt. Avoid accidents, clean up immediately. Dam up. Soak up with inert absorbent material. Pick up and transfer to properly labelled containers.
