**Methods and material for containment and cleaning up**

**Methods for containment** Stop leak if you can do it without risk. Remove ignition sources. Provide adequate ventilation. Do not touch or walk through spilled material. Dike far ahead of spill to collect runoff water. Soak up condensate with inert absorbent material and collect in ventilated waste container for disposal.

**Methods for cleaning up** Cover with damp absorbent (inert material, sand or soil). Vacuum or sweep material and place in a disposal container. Use non-sparking tools. Avoid generation of dust. Pick up and

transfer to properly labelled containers.

## 7. HANDLING AND STORAGE

### Precautions for safe handling

#### **Advice on safe handling**

Avoid breathing dust or spray mist. Avoid contact with skin, eyes, and clothing. Avoid generation of dust. Take precautionary measures against static discharges. Use personal protection equipment. Keep away from open flames, hot surfaces and sources of ignition. Use according to package label instructions. Handle in accordance with good industrial hygiene and safety practice.

#### **General hygiene considerations**

Remove and wash contaminated clothing and gloves, including the inside, before re-use. Regular cleaning of equipment, work area and clothing is recommended. Contaminated work clothing should not be allowed out of the workplace. Wash hands and face before breaks and immediately after handling the product. Wear suitable gloves and eye/face protection.
