Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal. Remove ignition sources. Provide adequate ventilation.
<b>Methods for cleaning up</b>	Dam up. Soak up with inert absorbent material. Use personal protective equipment as required. Pick up and transfer to properly labelled containers.
