6. ACCIDENTAL RELEASE MEASURES

Methods and material for containment and cleaning up

Dike far ahead of spill to collect runoff water. Keep out of drains, sewers, ditches and waterways. Remove ignition sources. Provide adequate ventilation. Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal.

Methods for cleaning up Slippery when spilt. Avoid accidents, clean up immediately. Take precautionary measures against static discharges. Use non-sparking tools. Dam up. Soak up with inert absorbent material. Pick up and transfer to properly labelled containers.
