#### **Description of first aid measures**

<b>General advice</b>	For advice, contact a Poisons Information Centre (e.g. phone Australia 13 11 26; New Zealand 0800 764 766) or a doctor.

Keep people away from and upwind of spill/leak. Do not touch or walk through spilled material. Evacuate personnel to safe areas. Wash thoroughly after handling. ### **Methods and material for containment and cleaning up**

**Methods for containment** Stop leak if you can do it without risk. Remove ignition sources. Provide adequate ventilation. Do not touch or walk through spilled material. Dike far ahead of spill to collect runoff water. Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal.

**Methods for cleaning up** Slippery when spilt. Avoid accidents, clean up immediately. Dam up. Soak up with inert absorbent material. Use personal protective equipment as required. Pick up and transfer to properly labeled containers.

### **Precautions for safe handling**
