#### Specific hazards arising from the chemical

**Specific hazards arising from the chemical** Combustible solid. On burning will emit toxic fumes, including those of oxides of carbon. In the event of fire, cool tanks with water spray. Fire residues and contaminated fire extinguishing water must be disposed of in accordance with local regulations. Most organic dusts are combustible and according to the circumstances under which the combustion process occurs, such materials may cause fires and/or dust explosions. Organic powders

when finely divided over a range of concentrations regardless of particulate size or shape and suspended in air or some other oxidizing medium may form explosive dust-air mixtures and result in a fire or dust explosion (including secondary explosions). Dusts in the form of a cloud are only ignitable over a range of concentrations; in principle, the concepts of lower explosive limit (LEL) and upper explosive limit (UEL) are applicable to dust clouds but only the LEL is of practical use; - this is because of the inherent difficulty of achieving homogeneous dust clouds at high temperatures (for dusts the LEL is often called the "Minimum Explosible Concentration", MEC).

When processed with flammable liquids/vapors/mists, ignitable (hybrid) mixtures may be formed with combustible dusts. Ignitable mixtures will increase the rate of explosion pressure rise and the Minimum Ignition Energy (the minimum amount of energy required to ignite dust clouds - MIE) will be lower than the pure dust in air mixture. The Lower Explosive Limit (LEL) of the vapour/dust mixture will be lower than the individual LELs for the vapors/mists or dusts.

Usually the initial or primary explosion takes place in a confined space such as plant or machinery, and can be of sufficient force to damage or rupture the plant. If the shock wave from the primary explosion enters the surrounding area, it will disturb any settled dust layers, forming a second dust cloud, and often initiate a much larger secondary explosion. All large-scale explosions have resulted from chain reactions of this type. Dry dust can be charged electrostatically by turbulence, pneumatic transport, pouring, in exhaust ducts and during transport. Build-up of electrostatic charge may be prevented by bonding and grounding. Powder handling equipment such as dust collectors, dryers and mills may require additional protection measures such as explosion venting. A sudden release of statically charged materials from storage or process equipment, particularly at elevated temperatures and/ or pressure, may result in ignition especially in the absence of an apparent ignition source. One important effect of the particulate nature of powders is that the surface area and surface structure (and often moisture content) can vary widely from sample to sample, depending on how the powder was manufactured and handled which means that it is virtually impossible to use flammability data published in the literature for dusts.

#### Personal precautions, protective equipment and emergency procedures

**Personal precautions** Evacuate personnel to safe areas. Ensure adequate ventilation. Avoid breathing dust/fume/gas/mist/vapors/spray. Avoid contact with skin, eyes or clothing. Do not touch or walk through spilled material. Wash thoroughly after handling. Keep people away from and upwind of spill/leak. Use personal protective equipment as required.

**For emergency responders** Shut off ignition sources. Clear area of all unprotected personnel. Use personal protection recommended in Section 8.

#### Environmental precautions

#### Methods and material for containment and cleaning up

**Methods for containment** Stop leak if you can do it without risk. Do not touch or walk through spilled material. Remove ignition sources. Provide adequate ventilation. Dike far ahead of spill to collect runoff water.

Soak up condensate with inert absorbent material and collect in ventilated waste container for disposal.

**Methods for cleaning up**

Dam up. Soak up with inert absorbent material. Vacuum or sweep material and place in a disposal container. Avoid generation of dust. Pick up and transfer to properly labeled containers.

**Section 7: Handling and storage****Precautions for safe handling****Advice on safe handling**

Avoid breathing dust or spray mist. Avoid contact with skin, eyes or clothing. Use personal protection equipment. Keep away from open flames, hot surfaces and sources of ignition. Use according to package label instructions. In common with many organic chemicals, may form flammable dust clouds in air. Take precautionary measures against static discharges. Handle in accordance with good industrial hygiene and safety practice.

**General hygiene considerations**

Regular cleaning of equipment, work area and clothing is recommended. Wash hands and face before breaks and immediately after handling the product. Wear suitable gloves and eye/face protection.

Keep containers tightly closed in a cool, well-ventilated place. Protect from sunlight. Store away from sources of heat or ignition. Store away from incompatible materials described in Section 10. Keep container closed when not in use.
