Non-combustible material. Decomposes on heating emitting toxic fumes including those of oxides of iron.

Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to products of decomposition. Collect contaminated extinguishing water separately, do not allow to reach sewage or effluent systems.

6. ACCIDENTAL RELEASE MEASURES

Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Wear protective equipment to prevent skin and eye contact and breathing in dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal. Wash area down with excess water.
