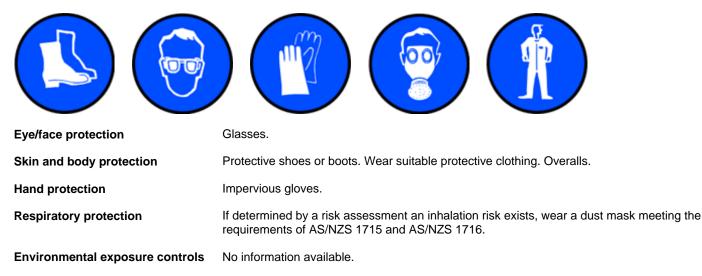

There were no observed adverse effects at exposures of 0.05 mg/m ³ . In addition, long-term medical monitoring of potentially exposed workers has not revealed lung effects such as those observed in the rat. However, the inhalation of respirable dusts should be avoided by implementing respiratory protection measures and observing the recommended permissible exposure limit of 0.05 mg/m ³ .

Polyacrylic acid has been classified by the International Agency for Research on Cancer (IARC) as a Group 3 -Not classifiable as to its carcinogenicity to humans.
