Wear protective equipment to prevent skin and eye contact and breathing in dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal.

Avoid use with known allergy or hypersensitivity to bupleurum species, its constituents or related members of the Apiaceae or Umbelliferae (carrot) families, snakeroot, cow parsnip, or poison hemlock family. Bupleurum has been reported to cause sedative effects, drowsiness and lethargy in some patients, along with decreased appetite, nausea, reflux, abdominal distension, flatulence, and increased bowel movements in large doses. Combinations containing bupleurum have been associated with eosinophilic pneumonia, pulmonary edema, and multiple cases of pneumonitis (inflammation of the lungs). Bupleurum may increase the risk of bleeding. Saikosaponins, constituents of Bupleurum, may increase blood sugar levels and have been found to both stimulate and inhibit the immune system. (1)
