Skin Contact:

Shut off all possible sources of ignition. If contamination of sewers or waterways has occurred advise local emergency services.

Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Wear protective equipment to prevent skin and eye contact and breathing in dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal.

Boldo intake had been linked to anaphalactic allergic reaction. Boldo may increase the risk of bleeding. It may cause hepatotoxicity (liver damage) and should be avoided by patients with liver disease. Boldo is thought to stimulate bile flow and, theoretically it may exacerbate bile duct obstruction. Boldo is not recommended in pregnant or breastfeeding women. Pregnant rats taking 800 mg/kg of crude extract of boldo and boldine by mouth demonstrated anatomical alterations in the foetus. (1)

Patients with kidney disorders, liver disease, gallstones and other medical illnesses should not use this herb. Boldo is known to be a CNS (Central Nervous System) stimulant. Large doses may cause paralysis and death. (2)
