**4. FIRST AID MEASURES**

**Description of first aid measures**

**Methods and material for containment and cleaning up**

**Methods for containment** Stop leak if you can do it without risk. A vapor suppressing foam may be used to reduce vapors. Dike far ahead of spill to collect runoff water. Keep out of drains, sewers, ditches and waterways. Remove ignition sources. Provide adequate ventilation. Absorb or cover with dry earth, sand or other non-combustible material and transfer to containers.

**Methods for cleaning up** Dam up. Soak up with inert absorbent material. Use non-sparking tools. Pick up and transfer to properly labelled containers.

**7. HANDLING AND STORAGE**

**Precautions for safe handling**

**Advice on safe handling** Avoid contact with skin, eyes, and clothing. Avoid breathing vapors or mists. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Use grounding and bonding connection when transferring this material to prevent static discharge, fire or explosion. Use with local exhaust ventilation. Use spark-proof tools and explosion-proof equipment. Take precautionary measures against static discharges. Keep in an area equipped with sprinklers. Use personal protection equipment. Use according to package label instructions. Keep out of reach of children.

**General hygiene considerations** Do not eat, drink or smoke when using this product. Contaminated work clothing should not be allowed out of the workplace. Regular cleaning of equipment, work area and clothing is recommended. Wash hands before breaks and immediately after handling the product. Avoid contact with skin, eyes, and clothing.
