Methods and material for containment and cleaning up

Methods for containment Stop leak if you can do it without risk. Remove ignition sources. Provide adequate ventilation. Dike far ahead of spill to collect runoff water. Absorb or cover with dry earth, sand or other non-combustible material and transfer to containers.

Methods for cleaning up Slippery when spilt. Avoid accidents, clean up immediately. Dam up. Soak up with inert absorbent material. Pick up and transfer to properly labelled containers.
