Dusts in the form of a cloud are only ignitable over a range of concentrations; in principle, the concepts of lower explosive limit (LEL) and upper explosive limit (UEL) are applicable to dust clouds but only the LEL is of practical use; - this is because of the inherent difficulty of achieving homogeneous dust clouds at high temperatures (for dusts the LEL is often called the "Minimum Explosible Concentration", MEC). Ignitable mixtures will increase the rate of explosion pressure rise and the Minimum Ignition Energy (the minimum amount ofenergy required to ignite dust clouds - MIE) will be lower than the pure dust in air mixture. 
