Methods and material for containment and cleaning up

Methods for containment Stop leak if you can do it without risk. Remove ignition sources. Provide adequate ventilation. Dike far ahead of spill to collect runoff water. Do not touch or walk through spilled material. Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal.

Methods for cleaning up Slippery when spilt. Avoid accidents, clean up immediately. Dam up. Soak up with inert absorbent material. Use personal protective equipment as required. Pick up and transfer to properly labelled containers.

According to current knowledge this concentration should neither impair the health of, nor cause undue discomfort to, nearly all workers.

These Workplace Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These workplace exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.
