**Methods for containment** Stop leak if you can do it without risk. Remove ignition sources. Provide adequate ventilation. Do not touch or walk through spilled material. Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal.

**Methods for cleaning up** Slippery when spilt. Avoid accidents, clean up immediately. Dam up. Soak up with inert absorbent material. Use personal protective equipment as required. Pick up and transfer to

properly labelled containers.

## 7. HANDLING AND STORAGE

### Precautions for safe handling

#### **Advice on safe handling**

No smoking. Use according to package label instructions. Handle in accordance with good industrial hygiene and safety practice.
