Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal.

Methods for cleaning up Take precautionary measures against static discharges. Use non-sparking tools. Dam up. Soak up with inert absorbent material. Pick up and transfer to properly labelled containers.
