**Inhalation**

Remove to fresh air and keep at rest in a position comfortable for breathing. If breathing is irregular or stopped, administer artificial respiration. Call a physician if symptoms occur.

**Eye contact**

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Keep eye wide open while rinsing. Do not rub affected area. Remove contact lenses, if present and easy to do. Continue rinsing. Call a physician if irritation persists.

**Skin contact**

Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. If skin irritation persists, call a physician.

**Ingestion**

### **Methods and material for containment and cleaning up**

**Methods for containment** Stop leak if you can do it without risk. Do not touch or walk through spilled material. A vapor suppressing foam may be used to reduce vapors. Dike far ahead of spill to collect runoff water. Keep out of drains, sewers, ditches and waterways. Remove ignition sources. Provide adequate ventilation. Absorb or cover with dry earth, sand or other non-combustible material and transfer to containers.

**Methods for cleaning up** Take precautionary measures against static discharges. Use non-sparking tools. Dam up. Soak up with inert absorbent material. Pick up and transfer to properly labelled containers.
