**Methods and material for containment and cleaning up**

**Methods for containment** Stop leak if you can do it without risk. Do not touch or walk through spilled material. Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal. Remove ignition sources. Provide adequate ventilation.

**Methods for cleaning up** Dam up. Soak up with inert absorbent material. Use personal protective equipment as required. Pick up and transfer to properly labelled containers. After cleaning, flush away traces with water.

## 7. HANDLING AND STORAGE

### Precautions for safe handling

**Advice on safe handling** Avoid contact with skin, eyes, and clothing. Avoid breathing vapors or mists. Wash thoroughly after handling. Use according to package label instructions. Handle in accordance with good industrial hygiene and safety practice. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking.
