**Personal precautions** Evacuate personnel to safe areas. Ensure adequate ventilation. Avoid breathing dust / fume / gas / mist / vapours / spray. Avoid contact with skin, eyes, and clothing. Do not touch or walk through spilled material. Wash thoroughly after handling. Use personal protective equipment as required. Keep people away from and upwind of spill/leak.

**For emergency responders** Shut off ignition sources. Clear area of all unprotected personnel. Use personal protection recommended in Section 8.

**Environmental precautions** Prevent further leakage or spillage if safe to do so. Refer to protective measures listed in Sections 7 and 8.

**Methods and material for containment and cleaning up**

**Methods for containment** Stop leak if you can do it without risk. Do not touch or walk through spilled material. Remove ignition sources. Provide adequate ventilation. Dike far ahead of spill to collect runoff water. Soak up condensate with inert absorbent material and collect in ventilated waste container for disposal.

**Methods for cleaning up** Slippery when wet. Dam up. Soak up with inert absorbent material. Vacuum or sweep material and place in a disposal container. Avoid generation of dust. Pick up and transfer to properly labelled containers.

## **7. HANDLING AND STORAGE**

**Precautions for safe handling**

**Advice on safe handling** Avoid breathing dust or spray mist. Avoid contact with skin, eyes, and clothing. Avoid generation of dust. Use personal protection equipment. Keep away from open flames, hot surfaces and sources of ignition. Use according to package label instructions. Handle in accordance with good industrial hygiene and safety practice. In common with many organic chemicals, may form flammable dust clouds in air. Take precautionary measures against static discharges.

**General hygiene considerations** Regular cleaning of equipment, work area and clothing is recommended. Wash hands and face before breaks and immediately after handling the product.
