### 4. FIRST AID MEASURES

**Description of first aid measures**

**General advice**

Call a physician if symptoms occur. Remove to fresh air and keep at rest in a position comfortable for breathing. If breathing is irregular or stopped, administer artificial respiration. If symptoms persist, call a physician.

**Eye contact**

Rinse immediately with plenty of water, also under the eyelids, for at least 15 minutes. Do not rub affected area. Remove contact lenses, if present and easy to do. Continue rinsing. Get medical attention if irritation develops and persists.

**Skin contact**

Wash off immediately with soap and plenty of water while removing all contaminated clothes and shoes. If skin irritation persists, call a physician.

**Ingestion**

Absorb or cover with dry earth, sand or other non-combustible material and transfer to containers.
