containers for later disposal.

Methods for cleaning up

Slippery when spilt. Avoid accidents, clean up immediately. Dam up. Soak up with inert absorbent material. Use non-sparking tools. Use personal protective equipment as required. Pick up and transfer to properly labelled containers.
