**Specific hazards arising from the chemical** Combustible liquid. On burning will emit toxic fumes, including those of oxides of carbon. In the event of fire, cool tanks with water spray. Fire residues and contaminated fire extinguishing water must be disposed of in accordance with local regulations.

**6. ACCIDENTAL RELEASE MEASURES**

**Personal precautions, protective equipment and emergency procedures**

**Personal precautions** Avoid contact with skin, eyes, and clothing. Avoid breathing vapors or mists. Ensure adequate ventilation. Do not touch or walk through spilled material. Keep people away from and upwind of spill/leak. Evacuate personnel to safe areas. Wash thoroughly after handling. Remove all sources of ignition. Use personal protective equipment as required.

**For emergency responders** Shut off ignition sources. Clear area of all unprotected personnel. Use personal protection recommended in Section 8.

**Environmental precautions** Prevent further leakage or spillage if safe to do so. Refer to protective measures listed in Sections 7 and 8.

**Methods and material for containment and cleaning up**

**Methods for containment** Stop leak if you can do it without risk. Remove ignition sources. Provide adequate ventilation. Dike far ahead of spill to collect runoff water. Do not touch or walk through spilled material. Absorb with earth, sand or other non-combustible material and transfer to containers for later disposal.

**Methods for cleaning up** Slippery when spilt. Avoid accidents, clean up immediately. Dam up. Soak up with inert absorbent material. Use personal protective equipment as required. Pick up and transfer to properly labelled containers.

**7. HANDLING AND STORAGE**

**Precautions for safe handling**

**Advice on safe handling** Avoid contact with skin and eyes. Avoid breathing vapors or mists. Ensure adequate ventilation. Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking. Take precautionary measures against static discharges. Wash thoroughly after handling. Use personal protection equipment. Use according to package label instructions. Handle in accordance with good industrial hygiene and safety practice.

**General hygiene considerations** Remove and wash contaminated clothing and gloves, including the inside, before re-use. Contaminated work clothing should not be allowed out of the workplace. Regular cleaning of equipment, work area and clothing is recommended. Wash hands and face before breaks and immediately after handling the product. Wear suitable gloves and eye/face protection.

**Storage Conditions** Keep containers tightly closed in a dry, cool and well-ventilated place. Keep away from open flames, hot surfaces and sources of ignition. Protect from direct sunlight. Store away from incompatible materials described in Section 10. Keep container closed when not in use.
