**Specific hazards arising from the chemical** Combustible liquid. Cool drums with water spray. Applying foam will release significant amounts of hydrogen gas that can be trapped under the foam blanket. Do not allow extinguishing medium to contact container contents. Most fire extinguishing media will cause hydrogen evolution, and once the fire is put out, may accumulate in poorly ventilated or confined areas and result in flash fire or explosion if ignited.
