4. FIRST AID MEASURES

5. FIRE FIGHTING MEASURES

Specific hazards arising from the chemical:

Non-combustible material.

Special protective equipment and precautions for fire-fighters:

Decomposes on heating emitting toxic fumes. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to products of decomposition. If safe to do so, remove containers from path of fire.

6. ACCIDENTAL RELEASE MEASURES

Emergency procedures/Environmental precautions:

Isolate spill or leak area immediately. If contamination of sewers or waterways has occurred advise local emergency services.

Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. DO NOT return spilled material to original container for re-use. After cleaning, flush away any residual traces with water.

Avoid skin and eye contact and breathing in vapour, mists and aerosols.

Store in a cool, dry, well ventilated place. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for leaks.
