Inhalation:

5. FIRE FIGHTING MEASURES

Suitable Extinguishing Media:

Non-combustible material.

Special protective equipment and precautions for fire-fighters:

Decomposes on heating emitting toxic fumes, including those of oxides of carbon , oxides of nitrogen , oxides of sulfur . Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to products of decomposition.

Emergency procedures/Environmental precautions:

Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal.

Store in a cool, dry, well ventilated place. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for leaks.
