4. FIRST AID MEASURES

Inhalation:

6. ACCIDENTAL RELEASE MEASURES

Emergency procedures/Environmental precautions:

Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal.

7. HANDLING AND STORAGE

Precautions for safe handling:

Avoid skin and eye contact and breathing in dust. Avoid handling which leads to dust formation. When using do not eat, drink or smoke. Wash hands before breaks and at the end of the work day. Take precautionary measures against static discharges.

Store in a cool, dry, well ventilated place. Keep containers closed when not in use - check regularly for spills.

TWA - The time-weighted average airborne concentration of a particular substance when calculated over an eight-hour working day, for a five-day working week.
