3. COMPOSITION AND INFORMATION ON INGREDIENTS

Product Description:

Substituted alkylphenol, 1-5%

Non-hazardous component(s), to 100%

4. FIRST AID MEASURES

Inhalation:

Ingestion:

Rinse mouth with water. If swallowed, give a glass of water to drink. If vomiting occurs give further water. Seek medical advice.

Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.

Clear area of all unprotected personnel. If contamination of sewers or waterways has occurred advise local emergency services.

Slippery when spilt. Avoid accidents, clean up immediately. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. Wash area down with detergent and excess water.
