## 5. FIRE FIGHTING MEASURES

### **Suitable Extinguishing Media:**

Fine water spray, normal foam, dry agent (carbon dioxide, dry chemical powder).

### Unsuitable Extinguishing Media:

Avoid skin and eye contact and breathing in dust. Avoid handling which leads to dust formation. May form flammable dust clouds in air. For precautions necessary refer to Safety Data Sheet "Dust Explosion Hazards". Take precautionary measures against static discharges. Ground all equipment containing material.

### Conditions for safe storage, including any incompatibilities:

Store in a cool, dry, well ventilated place. Maximum storage temperature: 5-30°C. Store away from sources of heat or ignition. Store away from incompatible materials described in Section 10. Keep containers closed when not in use check regularly for spills.
