# 4. FIRST AID MEASURES

### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Seek medical advice if effects persist. For fumes from molten material: remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered.

#### **Skin Contact:**

If skin contact occurs, remove contaminated clothing and wash skin with soap and water. If irritation occurs, seek medical advice. For skin burns, immediately flood burnt area with plenty of water. For skin burns, cover with a clean, dry dressing until medical help is available. If molten material should contact the skin and adhere, cool quickly with running water - do not attempt to remove. Seek immediate medical assistance.

### **Eye Contact:**

If in eyes, wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice. For contact with the molten material treat as for skin burns.

### Ingestion:

Rinse mouth with water. If swallowed, do NOT induce vomiting. Seek medical advice.

#### Indication of immediate medical attention and special treatment needed:

Treat symptomatically.

# 5. FIRE FIGHTING MEASURES

#### **Suitable Extinguishing Media:**

Fine water spray, normal foam, dry agent (carbon dioxide, dry chemical powder).

### **Unsuitable Extinguishing Media:**

Solid water jet/stream may scatter and spread the fire.

### Specific hazards arising from the chemical:

Combustible solid. Can melt and flow in a fire situation.

### Special protective equipment and precautions for fire-fighters:

On burning will emit toxic fumes, including those of oxides of carbon. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion. Keep containers cool with water spray. Can melt and flow in a fire situation.

# 6. ACCIDENTAL RELEASE MEASURES

### **Emergency procedures/Environmental precautions:**

If contamination of sewers or waterways has occurred advise local emergency services.

### Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours/dust. Collect and seal in properly labelled containers or drums for disposal. For the molten material: Contain - prevent run off into drains and waterways. Allow material to solidify.

# 7. HANDLING AND STORAGE

#### Precautions for safe handling:

Avoid skin and eye contact and breathing in vapour/dust. Wash hands thoroughly after handling.

Store in a cool, dry, well ventilated place. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for spills.

As published by Safe Work Australia Workplace Exposure Standards for Airborne Contaminants.

TWA - The time-weighted average airborne concentration of a particular substance when calculated over an eight-hour working day, for a five-day working week.

These Workplace Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These workplace exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

### Appropriate engineering controls:

Ensure ventilation is adequate and that air concentrations of components are controlled below quoted Workplace Exposure Standards. Natural ventilation should be adequate under normal use conditions. Molten material should be used in a well ventilated area. Keep containers closed when not in use.

When handling melt, or where there is a risk of being splashed with molten material: Wear overalls, chemical goggles, face shield, elbow-length impervious gloves, splash apron or equivalent chemical impervious outer garment, and rubber boots.
