4. FIRST AID MEASURES

Inhalation:

Non-combustible material.

Special protective equipment and precautions for fire-fighters:

Decomposes on heating emitting toxic fumes, including those of oxides of carbon, oxides of phosphorus. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to products of decomposition.

6. ACCIDENTAL RELEASE MEASURES

Emergency procedures/Environmental precautions:

If contamination of sewers or waterways has occurred advise local emergency services.

Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. Wash area down with excess water. Recover the cleaning water for subsequent disposal.

Store in a cool, dry, well ventilated place. Storage temperature: 20-30°C. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for leaks.
