Product Description: 100% Preparation based on: polyamide (PA 66), additives, fillers.

#### Inhalation:

Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal.

Avoid skin and eye contact and breathing in dust. Avoid handling which leads to dust formation. Take precautionary measures against static discharges.

Store in a cool, dry, well ventilated place. Protect from moisture. Keep containers closed when not in use - check regularly for spills.
