## 4. FIRST AID MEASURES

For advice, contact a Poisons Information Centre (e.g. phone Australia 131 126; New Zealand 0800 764 766) or a doctor.

#### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. If patient finds breathing difficult and develops a bluish discolouration of the skin (which suggests a lack of oxygen in the blood - cyanosis), ensure airways are clear of any obstruction and have a qualified person give oxygen through a face mask. Apply artificial respiration if patient is not breathing. Seek immediate medical advice.

#### **Skin Contact:**

If skin or hair contact occurs, immediately remove any contaminated clothing and wash skin and hair thoroughly with running water and soap. If swelling, redness, blistering or irritation occurs seek medical assistance.

#### **Eye Contact:**

If in eyes, hold eyelids apart and flush the eye continuously with running water. Continue flushing until advised to stop by a Poisons Information Centre or a doctor, or for at least 15 minutes.

#### Ingestion:

Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water. Seek medical advice.

#### **Suitable Extinguishing Media:**

Alcohol resistant foam is the preferred firefighting medium but, if it is not available, fine water spray or water fog can be used.

#### Specific hazards arising from the chemical:

Flammable liquid. May form flammable vapour mixtures with air. Vapour may travel a considerable distance to source of ignition and flash back. Environmentally hazardous.

#### Special protective equipment and precautions for fire-fighters:

Heating can cause expansion or decomposition of the material, which can lead to the containers exploding. If safe to do so, remove containers from the path of fire. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.

### 6. ACCIDENTAL RELEASE MEASURES

#### **Emergency procedures/Environmental precautions:**

Isolate spill or leak area immediately. Clear area of all unprotected personnel. Shut off all possible sources of ignition. Ventilate closed spaces before entering. Ventilate spill area. Do not allow container or product to get into drains, sewers, streams or ponds. If contamination of sewers or waterways has occurred advise local emergency services.

### Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material), Collect and seal in properly labelled containers or drums for disposal. Use non-sparking tools. After cleaning, flush away any residual traces with water.

### 7. HANDLING AND STORAGE

#### Precautions for safe handling:

Avoid skin and eye contact and breathing in vapour, mists and aerosols. All potential sources of ignition (open flames, pilot lights, furnaces, spark producing switches and electrical equipment etc) must be eliminated both in and near the work area. Do NOT smoke.
