## 5. FIRE FIGHTING MEASURES

## 6. ACCIDENTAL RELEASE MEASURES

### Emergency procedures/Environmental precautions:

If contamination of sewers or waterways has occurred advise local emergency services.

### Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal. After cleaning, flush away any residual traces with water.

## 7. HANDLING AND STORAGE

### Precautions for safe handling:

Avoid skin and eye contact and breathing in dust. Avoid handling which leads to dust formation. Wash hands before breaks and at the end of the work day. Do not wear contact lenses.

### Conditions for safe storage, including any incompatibilities:

Store in a cool, dry, well ventilated place. Store between 0°C and 30°C. Store away from incompatible materials described in Section 10. Keep containers closed when not in use - check regularly for spills.

TWA - The time-weighted average airborne concentration of a particular substance when calculated over an eight-hour working day, for a five-day working week.

These Workplace Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These workplace exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

## Appropriate engineering controls:

Ensure ventilation is adequate to maintain air concentrations below Workplace Exposure Standards. Keep containers closed when not in use.
