## 5. FIRE FIGHTING MEASURES

### Suitable Extinguishing Media:

Fine water spray, normal foam, dry agent (carbon dioxide, dry chemical powder).

### Specific hazards arising from the chemical:

Combustible liquid. Containers may rupture or explode in heat of fire.

### Special protective equipment and precautions for fire-fighters:

On burning will emit toxic fumes, including those of oxides of carbon. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion. Keep containers cool with water spray.

## 6. ACCIDENTAL RELEASE MEASURES

### Emergency procedures/Environmental precautions:

Clear area of all unprotected personnel. Shut off all possible sources of ignition. If contamination of sewers or waterways has occurred advise local emergency services.

### Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. Wash area down with detergent and excess water. For large amounts: Dike spillage. Pump off product.

## 7. HANDLING AND STORAGE
