Methods and materials for containment and cleaning up Prevent entry into waterways, sewer, basements or confined areas.

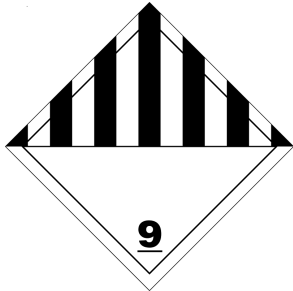

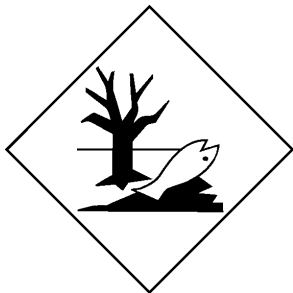
