Carbon black contains varying amounts of polynuclear aromatic compounds which have been found to cause cancer in animals. Solvent extracts of carbon black are carcinogenic to the skin of mice. It is classified by IARC to be a known animal carcinogen and a possible human carcinogen (Group 2B).
