## 4. FIRST AID MEASURES

### Inhalation:

Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

### Skin Contact:

If skin contact occurs, remove contaminated clothing and wash skin with soap and water. If irritation occurs, seek medical advice. If molten material should contact the skin and adhere, cool quickly with running water - do not attempt to remove. Seek immediate medical assistance.

### Eye Contact:

If in eyes, wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice. For contact with the molten material treat as for skin burns.

**Ingestion:**

## 5. FIRE FIGHTING MEASURES

**Suitable Extinguishing Media:**

Fine water spray, normal foam, dry agent (carbon dioxide, dry chemical powder).

**Specific hazards arising from the chemical:**

Combustible solid.

**Special protective equipment and precautions for fire-fighters:**

On burning will emit toxic fumes, including those of oxides of carbon, acrylates, methacrylates and other organic materials. May form flammable vapour mixtures with air. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.

## 6. ACCIDENTAL RELEASE MEASURES

**Emergency procedures/Environmental precautions:**

Shut off all possible sources of ignition. Increase ventilation. If contamination of sewers or waterways has occurred advise local emergency services.

**Personal precautions/Protective equipment/Methods and materials for containment and cleaning up:**

Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contact and breathing in dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust. Collect and seal in properly labelled containers or drums for disposal.

## 7. HANDLING AND STORAGE

**Precautions for safe handling:** Avoid skin and eye contact and breathing in dust, vapour or mist that may be formed during processing. Avoid handling which leads to dust formation. In common with many organic chemicals, may form flammable dust clouds in air. For precautions necessary refer to Safety Data Sheet "Dust Explosion Hazards". Take precautionary measures against static discharges.

**Conditions for safe storage, including any incompatibilities:** Store in a cool, dry, well ventilated place. Store away from sources of heat or ignition. Keep containers closed when not in use - check regularly for spills.

## 8. EXPOSURE CONTROLS/PERSONAL PROTECTION

**Workplace Exposure Standards:** No value assigned for this specific material by the New Zealand Workplace Health & Safety Authority. However, supplier recommended Exposure Standard(s):

WES - TWA (Workplace Exposure Standard - Time Weighted Average) - The eight-hour, time-weighted average exposure standard is designed to protect the worker from the effects of long-term exposure.

These Workplace Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These workplace exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

## Appropriate engineering controls:

Ensure ventilation is adequate and that air concentrations of components are controlled below quoted Workplace Exposure Standards. In general, ventilation should be provided at compounding and converting areas and at fabricating work stations which involve heating the plastic. Local exhaust hoods may be used over die-heads of extrusion equipment or in the vicinity of thermoforming and moulding machines, where practicable. Keep containers closed when not in use.

If in the handling and application of this material, safe exposure levels could be exceeded, the use of engineering controls such as local exhaust ventilation must be considered and the results documented. If achieving safe exposure levels does not require engineering controls, then a detailed and documented risk assessment using the relevant Personal Protective Equipment (PPE) (refer to PPE section below) as a basis must be carried out to determine the minimum PPE requirements.

## Individual protection measures, such as Personal Protective Equipment (PPE):

Wear overalls, safety glasses and impervious gloves. Avoid generating and inhaling dusts. If determined by a risk assessment an inhalation risk exists, wear a dust mask/respirator meeting the requirements of AS/NZS 1715 and AS/NZS 1716. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use.

## 10. STABILITY AND REACTIVITY

**Reactivity:** No information available.

**Skin contact:** Contact with skin may result in irritation. Contact with hot material may cause skin burns.

**Inhalation:** Breathing in dust may result in respiratory irritation. Vapour and processing fumes may cause irritation to mucous membranes of the respiratory tract, headache and nausea.
